## **NEW BUSINESS**

Recommendation for Award- 2017 Asphalt and Bituminous-Coated Aggregate

Dave Payne, Purchasing Manager, recommended approval of the Recommendation for Award of the Asphalt and Bituminous-Coated Aggregate to all bidders which include Asphalt Materials, Central Paving, Marathon Petroleum, Milestone Contractors and Rieth-Riley. It is in the best interest of both government agencies to seek the supplier with the lowest bid first and with consideration based on availability. Mrs. Murray moved for approval. Mr. Murtaugh seconded. Motion Carried.
