**Welcome and Call to Order**

Jos Holman welcomed everyone to the Redevelopment Commission meeting, noted that a quorum was present and opened the meeting of the Lafayette Redevelopment Commission at 11:17am (following the Redevelopment Authority meeting).

**Minutes**

Shelly Henriott moved to approve the minutes of the January 27, 2022 meeting, with a scrivener's error noted and corrected. Frank Donaldson seconded and the motion passed.

**New Business**

**Resolution LRC-2022-02:** *Amending Declaratory Resolution of the Lafayette Redevelopment Commission Amending the Consolidated Plan for the Consolidated Creasy/Central Economic Development Area* – Dennis Carson presented this resolution that amends the development plan for the Consolidated Creasy/Central Economic TIF District to include the Public Works Campus as an eligible project for Creasy TIF funding. Jacque Chosnek stated that the Resolution was needed to commit those TIF funds regardless of traditional bonding or the Bid-Operate-Transfer (BOT) protocol (as in this case). James Foster moved to approve. Shelly Henriott seconded. The motion passed unanimously.

**Resolution LRC-2022-03:** *Amending Declaratory Resolution of the Lafayette Redevelopment Commission Amended the Development Plan for the McCarty Economic Development Area*- Dennis Carson presented this resolution that amends the development plan for the McCarty Economic Development TIF District to include the Public Works Campus as an eligible project for McCarty TIF funding. Jacque Chosnek stated that the Resolution was needed to commit those TIF funds regardless of traditional bonding or BOT protocol. Shelly Henriott moved to approve. Frank Donaldson seconded. The motion passed unanimously.

**Main Street Streetscape Phase IV (HWC):**

**Recommendation of Award and Notice of Award** -At the January 27, 2022 meeting, the Redevelopment Commission received three bids for the Main Street Streetscape Project. Milestone Contractors was the lowest and most responsible bidder. We are recommending to award the contract to them. Shelly Henriott moved to approve. Frank Donaldson seconded. The motion passed unanimously.

**Contract award** – The contract amount for the project is to be \$1,274,400.00, awarded to Milestone Contractors. Shelly Henriott moved to approve. James Foster seconded. The motion passed unanimously.

**Notice to proceed** – The Notice to Proceed for Milestone Contractors includes a start date of March 1<sup>st</sup> with substantial completion by November 1<sup>st</sup> and final completion by December 1, 2022. Shelly Henriott moved to approve. Frank Donaldson seconded. The motion passed unanimously.

**Director’s Report**

Annette Basham of J.S. Held reported that the Public Safety Center is making progress every day. A few weather delays have occurred but the roof is 90% complete, the building interior stairwells are 100% complete and the garage stairwells are 98% complete. The project is on time and within budget. Columbia Street will be closed February 25<sup>th</sup> and 26<sup>th</sup> in order to dismantle the tower crane. All appropriate parties have been notified of the closure.

**Claims**

Shelly Henriott moved to approve the February 2022 claims in the amount of Two Million, Six Hundred Thirty Thousand, One Hundred Thirteen Dollars and Eighty-Six Cents (\$2,630,113.86). James Foster seconded and the motion passed unanimously.


**Public Comment**-none
