

## Some Examples of Discriminatory Treatment

---

- A landlord tells you a unit is no longer available when they see you are not white.
- You are unable to rent an apartment in a building because you have children.
- An employer asks questions of female applicants which are not asked of males.
- You are discharged from employment in retaliation for complaining about a discriminatory company practice.
- When you begin to look pregnant, you are told to move out of your apartment.
- You are denied seating in a restaurant which has available space because of your race.
- A hotel owner refuses to provide a double bedroom to two men.
- An employer decides not to offer you a job due to your disability even though you are the most qualified candidate.
- A bank refuses you a loan because of your religion.

## Indiana Civil Rights Commission

---

The Indiana Civil Right Commission (ICRC) enforces the civil rights laws of the State of Indiana. The ICRC investigates complaints of discrimination and educates organizations, companies, landlords, associations and individuals on their rights and responsibilities under Indiana Civil Rights Laws.

## PURPOSE

---

The City of Lafayette's Human Relations Commission (HRC) was created in 1968.

### Its purposes are:

- To end prejudice, intolerance, bigotry and discrimination in the City of Lafayette.
- To encourage respect and understanding of all individuals and groups.
- To investigate complaints of discrimination in the City of Lafayette based on race, sex, religion, color, handicap, familial status, national origin, sexual orientation or gender identity.

### In the areas of:

- Employment
- Access to public accommodations
- Purchase or rental of housing

**The City of Lafayette HRC defines discrimination as any difference in the treatment of a person including exclusion or segregation because of race, sex, religion, color, sexual orientation, handicap, familial status, national origin, gender identity, age or veteran status.**

## MEETINGS

---

The Human Relations Commission holds regular meetings quarterly.

The meetings are held at a handicap accessible location and are open to the public. Contact the City of Lafayette's Human Resources Department to confirm the time and meeting place.

## MEMBERS

---

The commission consists of nine (9) citizens appointed by the Mayor. All members are non-paid volunteers.

## WHAT SHOULD I DO?

---

If you think you have been discriminated against, file a complaint with the *Lafayette Human Relations Commission* **no later than 90 days** after the act of discrimination occurred.

*Complaints of discrimination may also be filed with certain agencies of the State and Federal government or suits may be filed in court in some cases. Consult with your own attorney for further information.*
